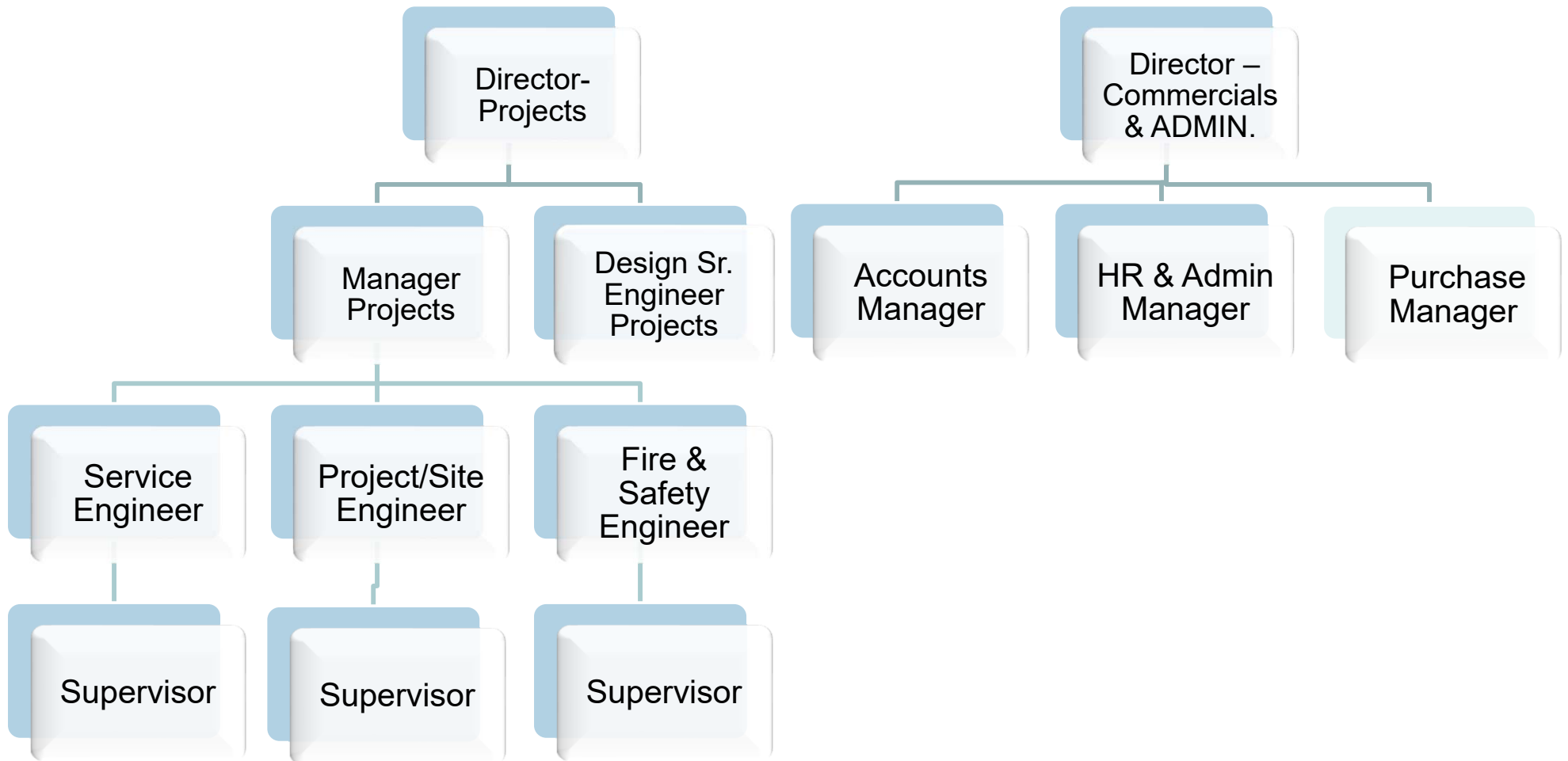

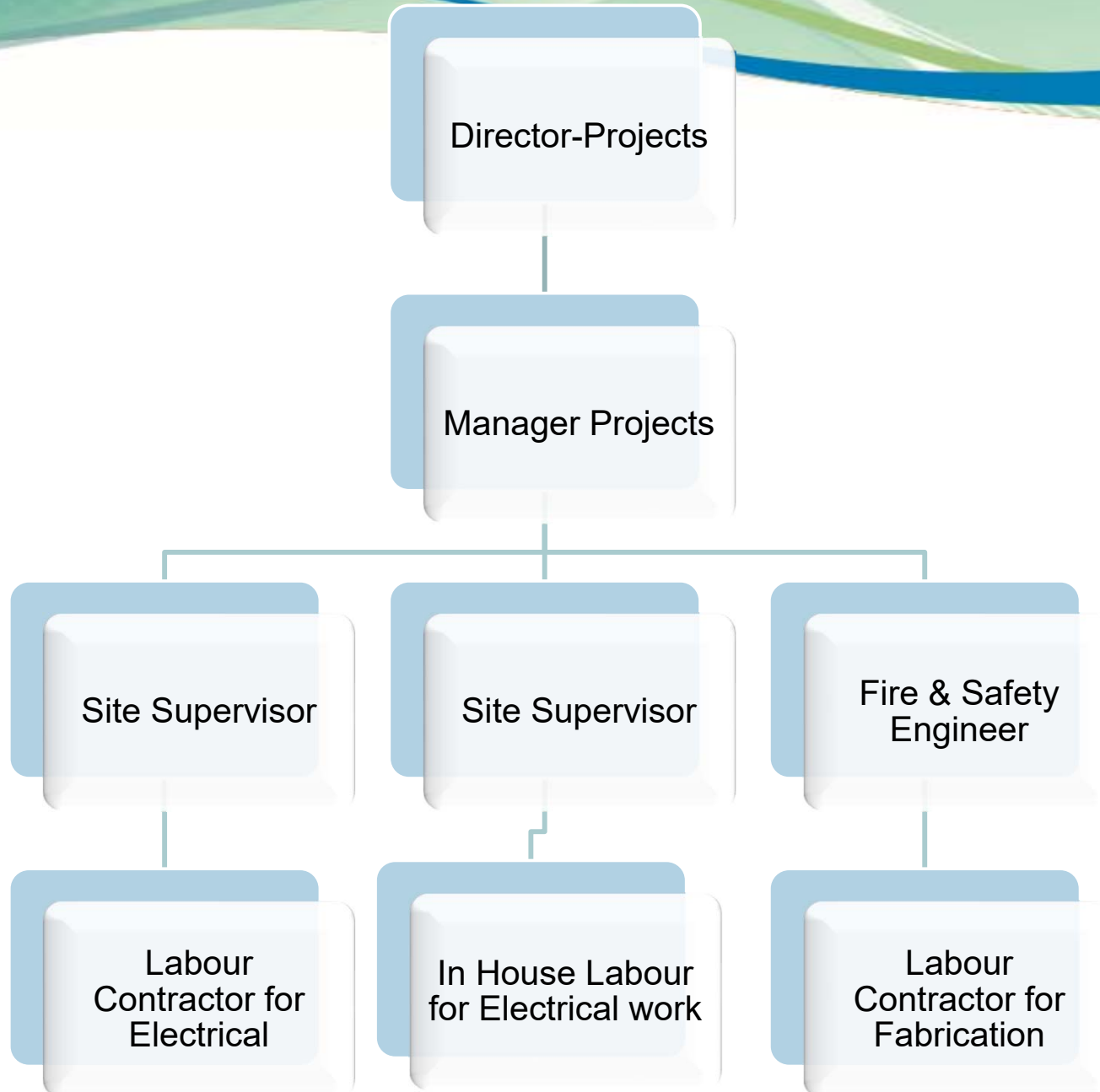

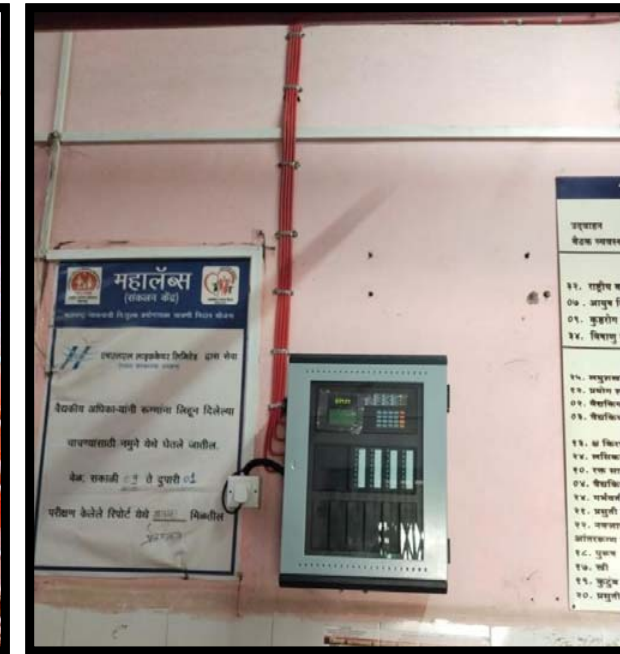

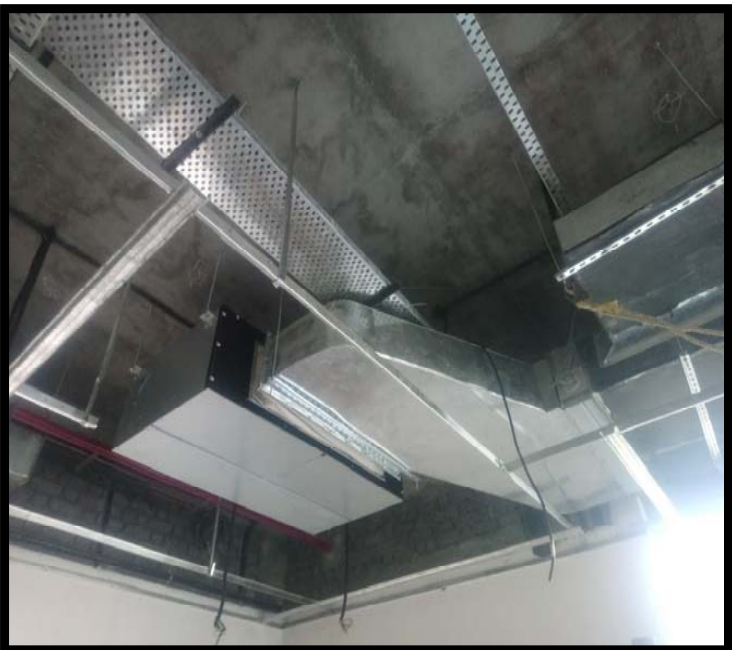

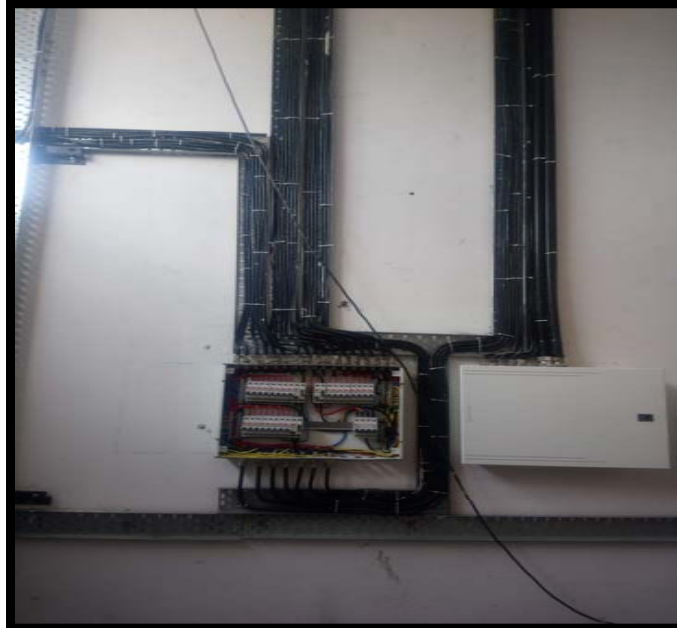


# HVAC project snaps completed successfully
